# Background and Objectives

In 1995, the German Physicians Selfgovernmental Bodies established a national **Agency for Quality in Medicine** (AQuMed) in order to promote quality in healthcare.

In 1998, AQuMed started a multifaceted strategy aiming at nation wide dissemination and implementation of Evidence based Medicine (**including Eb Guidelines**).

The presentation describes the strategy's tools and activities, as well as its influence on health policy in Germany 2003.



# Study Design

The project aimed at

- (1) consensus on a national policy for evidence based health care in Germany;
- (2) networking people and organisations interested in the EBM field;
- (3) development of EBM focused educational strategies for consumer, health care provider and policy maker;
- (4) broad availability and use of EB information (**guidelines**).

For that purpose, AQUMED initiated multiple working groups, national meetings bringing together the expertise of more than 300 individuals of all parts of the health care system.

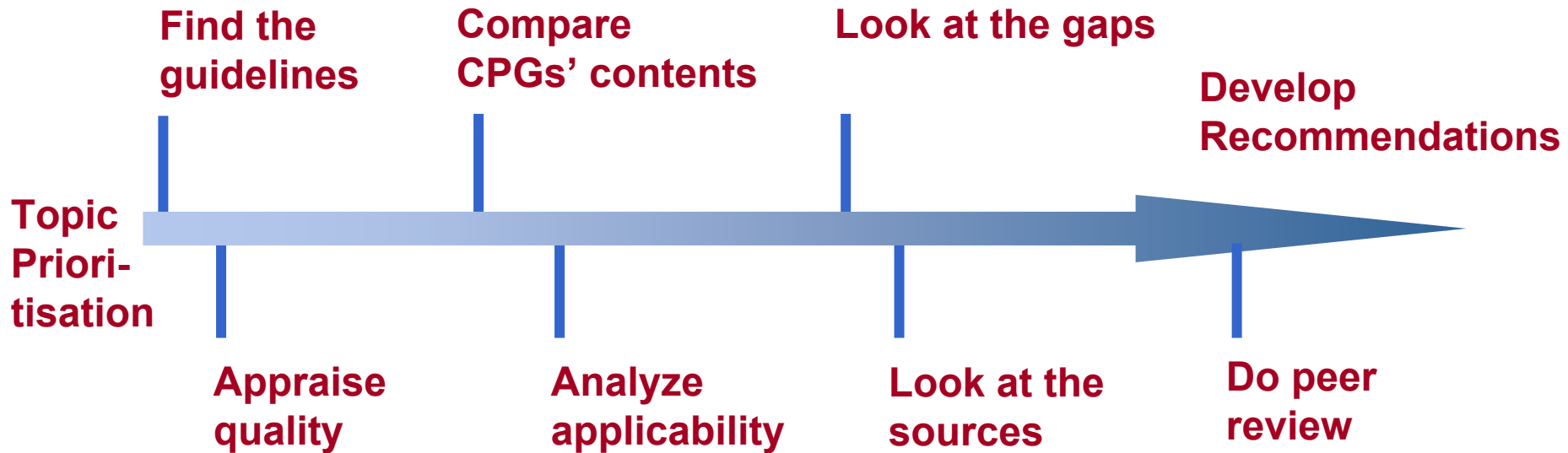

## A. Local tailoring / implementation of EBG in outpatient care



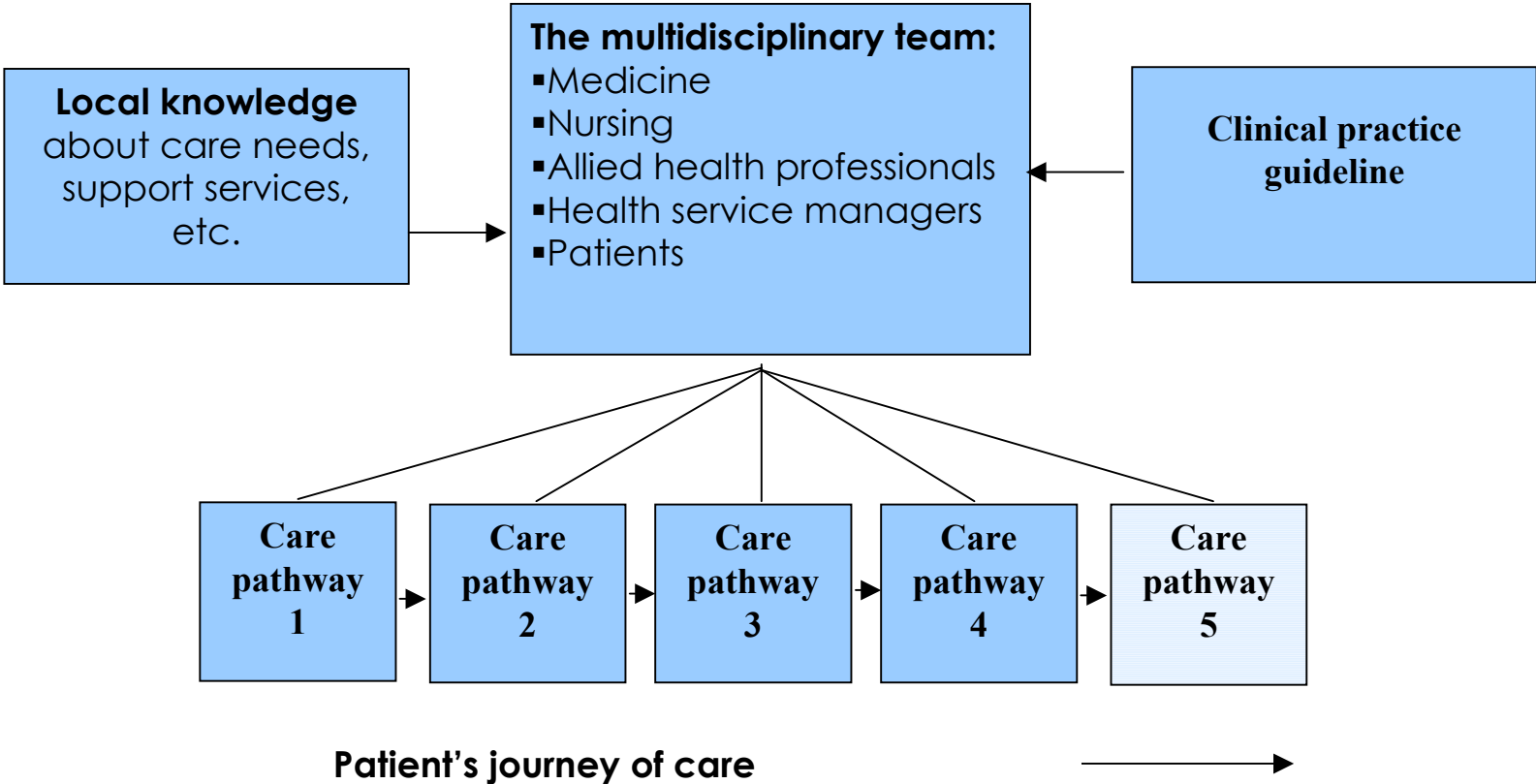

# Conclusion

Within 5 years after the project's start, the major national and regional associations and organisations of health care provider, consumer, and sickness funds in Germany have been adapting basic ideas, of Evidence based Medicine, as well as tools and procedures (guidelines + guideline implementation strategies) .

The Federal Parliament passed amendments to the National Social Code making the use of evidence based information (f.e. guidelines and HTA) mandatory for statutory health insurance programmes.
