

G-I-N 2020 Postponement FAQ

General

What is the status of the G-I-N 2020 Conference in Toronto?

The G-I-N Conference in Toronto has been postponed to September 21-24, 2022 at the Hotel Westin Harbourcastle, due to the COVID-19 outbreak.

Why has G-I-N 2020 been postponed?

The G-I-N Board of Directors and Local Organizing Committee put the health and welfare of participants and the local host community at the forefront of their decision making. The travel restrictions currently in place make it unsuitable to continue with the planning for a 2020 Conference.

When and where will G-I-N 2022 take place?

The G-I-N Conference in Toronto has been postponed to September 21-24, 2022.

Refunds

Will my hotel room reservation be refunded?

If you have made a hotel room reservation within the official block of the conference partner hotels, your reservation has been released without penalty. For additional information, please contact registration@ginconference.net.

Will my airfare be refunded?

Please ask your travel agent/airline and let them know you are cancelling or modifying your booking due to the postponement of G-I-N 2020. The responsibility for airfare bookings and refunds falls outside the scope of G-I-N 2020 and will be dependent on the type of fare booked and any travel insurance coverage.

Can I transfer my registration fee to GES 2 in 2021 or 2022?

If you have registered for the 2020 conference, your fees will automatically be refunded and you will receive a confirmation of the refund by email.

Your sponsorship/exhibit fees will be refunded and the agreement cancelled. Please allow 6-8 weeks for processing. We hope that you will commit to exhibiting and/or sponsoring the conference in 2022.
